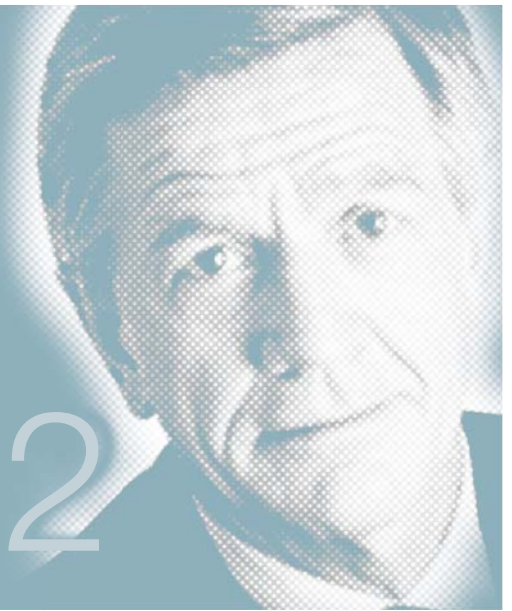


The Economic Verdict 2012
